Re: Public Records Act Request

Dear Mr. Figueroa:

On June 14, 2013, we received a Public Records Act request from you, postmarked June 12, 2013. You request the following:

Any and all documents or information concerning medical marijuana, Proposition 215 (codified as Health and Safety Code § 11362.5), Senate Bill 420 (codified as Health and Safety Code §§ 11362.7-11362.83), including, but not limited to, any and all guidelines, bulletins, orders, directives, policies, and/or protocols. Please provide any and all documents or information concerning medical marijuana doctors, patients, caregivers, dispensaries, collectives, cooperatives and/or associations.

Your letter does not include any time frame for the documents. As you know, we have responded to previous Public Records Act requests on July 26, 2010; July 11, 2011; and July 2, 2012. I assume that you are not seeking a duplicate copy of those documents. I am interpreting your current request as covering documents we have created or obtained after the previous requests.

Enclosed are documents responsive to your request. In the light of the small volume of materials, we are not requesting reimbursement for duplication fees.

We are **not** providing documents that are exempt from disclosure under the following authority:
