Beginning in 1965 when American Indians first received a federal exemption for religious use of peyote, lawmakers and jurists have wrestled with how to reconcile religious liberties with drug prohibition, resulting in a substantial body of US law that defines the rights of religious communities who work with entheogenic plants and fungi. This presentation will provide a general overview of the legal issues confronting entheogenic religious communities arising under federal law, with particular attention given to the First Amendment, the Religious Freedom Restoration Act, and the Religious Land Use and Institutionalized Persons Act.

This panel will discuss the ongoing issues of cannabis prohibition in California, New York, and internationally despite the creation and development of the commercial cannabis marketplaces in these areas. Omar Figueroa will discuss ongoing issues in California’s market, including problems posed by California’s local opt-out regulations; New York state’s approach to implementing a commercial cannabis marketplace; and outstanding issues related to social equity that persist. Richard Clabaugh will present a short history of cannabis prohibition in Germany, German medical cannabis law and its implications for an adult-use market, and the legislative process and status of the legalization and draft legislation. He will conclude by presenting the current status of Novel Foods applications before the European Food Safety Administration and possibility for the sale of CBD and other cannabinoids, in food and drink in Germany and Europe.

This panel aims to explore the intersection of the law of psychedelic compounds and the psychedelic practice of law. What opportunities and challenges does the evolving legal status of psychedelic compounds present for the practice of law? Legal access to and use of psychedelics raises questions and concerns many cannabis lawyers may not yet have considered. There are inherent tensions between the duties of private sector and government attorneys, as reflected in the Oregon Rules of Professional Conduct, as well as statutes and case law, and the desire to honor the profound religio-spiritual and cultural traditions implicated in any legalization initiative and provide an individually meaningful and equitable form of public access and choice concerning psychedelic compounds.
